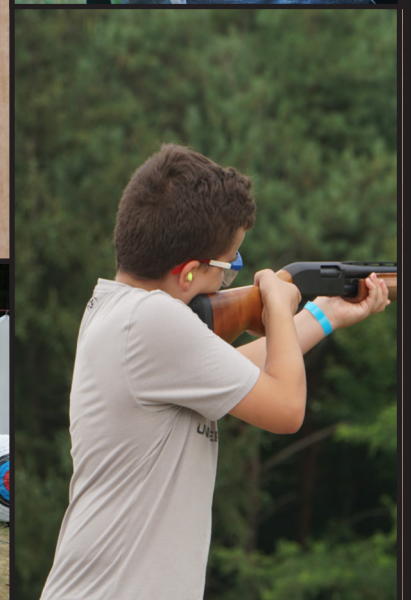

The Program

The Michigan Out-of-Doors Youth Camp is held for six weeks during the summer at the Cedar Lake Outdoor Center near Chelsea, MI. Our camp is special because it focuses on engaging campers in the outdoors and connecting them with the environment. Our unique curriculum teaches outdoor skills such as target shooting, hunter safety, camping and wilderness survival.

During their week at camp, campers dive into hands-on nature experiences and self-discovery in order to increase their knowledge of ecological concepts and broaden their awareness of conservation issues. There will also be opportunities to practice technical skills such as fishing and hunting techniques, along with time spent at the rifle and archery range. Our inquiry-based curriculum allows campers to investigate the natural world around them while gaining new skills and confidence in the outdoors. A focus on Michigan's natural resources and each person's role in the environment is what sets us apart from a typical summer camp. Campers are kept in small groups of not more than 15 to ensure they receive individualized instruction and to keep each camper safe while in our care. Extensively trained staff members work to deliver quality instruction and are held to the highest standards at all times.

Our goal is for campers to return home feeling positive about their experience and excited about the new skills they learned at camp.

The Outdoor Center

Michigan United Conservation Clubs has operated summer youth camp programs since 1946. During this time, more than 58,000 youth have learned to enjoy the outdoors safely and have left camp with a deeper appreciation and respect for the natural world. Completed in 1940, the Cedar Lake Outdoor Center is rich in Michigan history. It was built by the Civilian Conservation Corps and has been maintained by the DNR and MUCC in the years since. The rolling landscape, white pine forest and waterfront all provide an abundance of wildlife and beauty.

We are privileged to call Cedar Lake home and have spent a great deal of time and effort restoring the facilities and making improvements to the camp for the enjoyment of our campers. We are located within the beautiful Waterloo State Recreation Area, and our property spans 225 acres, which includes beachfront access to Cedar Lake. With the help of countless volunteers, the staff and our awesome campers, we have been providing top-notch conservation education programs and connecting kids to the natural world around them for many years.

We couldn't be happier to be a part of the historic Cedar Lake Outdoor Center. We are excited to have your youth join us for the 2022 season and be a part of our program!

The Staff

Michigan United Conservation Clubs carefully recruits its camp staff from various colleges and universities throughout Michigan and the rest of the country. We select candidates who have knowledge of conservation, outdoor skills and environmental education, as well as demonstrate a mature and responsible attitude.

Background checks are completed for all staff hired and participation in a week-long training session is a requirement. During training, our camp staff learns various teaching techniques, camper motivation, behavior management, leadership and emergency procedures in addition to the many different curriculums they will be instructing. The waterfront personnel, range instructors and health director all meet or exceed the requirements of the Department of Licensing and Regulatory Affairs for the State of Michigan. We are proud of the staff at Cedar Lake Outdoor Center and assure you that the utmost care will be taken to provide a safe and encouraging atmosphere for your child at camp. As a State of Michigan-licensed camp, we not only meet the requirements of several inspections, we strive to go above those requirements in order to deliver the best experiences for your child.

DAY CAMP (NON-RESIDENTIAL) **WEEK 1 – AGES 5-8, 9 A.M. TO 4 P.M.**

\$300

We are on an adventure to discover the outdoors for the younger campers. During this week, campers will explore the world around them and have the chance to get hands-on with nature. Campers will spend time each day learning about a different area of Michigan's ecosystems. Each day they will have a chance to swim and do crafts. They will also spend time canoeing and learning basic archery. Parents must provide a packed lunch and swimsuit each day.



CONSERVATION CONNECTION **WEEKS 1, 2 & 6 – AGES 9-11**

\$500

Considered our "sampler camp," this week of activities fits in as much variety as possible. We will be covering kayaking, fishing, survival skills, wildlife surveys, hiking, archery and more! There are plenty of hands-on outdoor activities for your camper to discover their outdoor interest!

FISHING CAMP **WEEKS 1, 2 & 6 – AGES 9-11**

\$500

Grab your tackle and join us for this week full of fishing fun! Campers will have the opportunity to do plenty of shore fishing, as well as kayak fishing, while learning new skills and techniques to get them to start thinking about angling in new ways. Occasionally, we will put our poles down to enjoy a lesson in water ecology or construct our very own lures!



WETLAND WONDERS **WEEK 1, 2 & 6 – AGES 9-11**

\$500

Michigan is the Great Lakes state! This camp is designed to get our campers out and exploring the water. Wetland Wonders campers will visit and learn about bogs, swamps, lakes and ponds. We will examine aquatic plants, catch macro invertebrates, search for reptiles and amphibians, fish Cedar Lake to get a better look at fish, along with kayaking, survival skills, wildlife surveys, archery and more!

FANTASTIC FORESTS **WEEK 2 & 6 – AGES 9-11**

\$500

Michigan has unbelievable woodlands, and this camp's purpose is to get our campers into them! We will be hiking the property to observe ecosystems, identify trees, find wild edibles, explore the birds that live in the canopy and discover the other wildlife that inhabits the forest, along with kayaking, fishing, survival skills, wildlife surveys, archery and more!

FUR HARVESTERS **WEEK 3 – AGES 12-14**

\$500

This is an exciting program where campers learn the essentials of becoming an ethical fur harvester. Our lead educator this week will give our campers first-hand experience in setting lines and developing scouting techniques. Campers will have the opportunity to complete the Michigan Trapper Education program and become a certified Michigan Trapper.



HUNTING HERITAGE **WEEKS 3, 4 & 5 – AGES 12-14**

\$500

This is a week of hunting techniques and strategies. We will cover the responsibility of ethical sportsmen and women, identify our campers roles as stewards of the land, track and I.D., as well as cover the importance of choosing the right equipment for your hunt. We will have speakers provide insight for your campers and demonstrate how to hunt safely and effectively.

WILDERNESS SURVIVAL **WEEKS 3, 4 & 5 – AGES 12-14**

\$500

This is a chance for our campers to get back to the basics of wilderness survival! This camp will go from training on our 3-D archery range to constructing shelters using only what our white pine forest provides them. Our curriculum will further each campers' understanding of the survival resources available, no matter the situation.

COUNSELOR IN TRAINING **WEEKS 4 & 5 – AGES 15-16**

\$500

The CIT program offers former campers the opportunity to become Conservation Educators. CIT participants will be paired with staff members to help lead camp programming and develop leadership, public speaking and communication skills. Counselors in Training must complete a separate application and interview process. For more information, please contact the camp director.

STEWARDS IN TRAINING **WEEKS 4 & 5 – AGES 14-15**

\$500

This one-week camp has a focus on creating young leaders and longtime conservationists. Stewards in training campers have the task of working together to problem solve to tackle challenges that will test them mentally and physically. Two of the largest events facing this group of campers is a day traversing a high ropes course and a 15-mile, overnight, backpacking trip through the Waterloo Recreation Area.

Release, Indemnification and Hold Harmless Agreement:

In consideration of participating in camp activities, and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence Michigan United Conservation Clubs and its owners, directors, officers, employees, agents, volunteers, participants and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees") on behalf of myself and my children, parents heirs assigns, personal representative and estate and also agree as follows:

I acknowledge that participating in camp activities involves known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage. Risks include but are not limited to, broken bones, torn ligaments or other injuries as a result of falls or contact with other participants; death as a result of drowning or brain damage caused by near drowning in pools or other bodies of water; medical conditions resulting from physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.

I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of the Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity, or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage to myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity or else I am willing to assume – and bear the costs – of all risks that may be created, directly or indirectly, by any such condition. In the event that I file a lawsuit, I agree to do so solely in the state

where Releasees' facility is located, and I further agree that the substantive law of the state shall apply. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

Standards and Agreement:

PARENTS/GUARDIANS: Please review the following standards agreement with your camper. By signing your child up for camp you and your child agree to the rules listed below. MUCC and the Michigan OUTofDOORS Youth Camp staff take pride in providing a safe and fun place to learn and explore while at camp.

1. Do not ask your camper to call home during his/her stay at camp. Most often, camper's "homesickness" intensifies after calling home and can usually be resolved on site. If the issue cannot be resolved in a reasonable amount of time the Director will call your home
2. Do not allow your camper to bring candy, chips, cookies, ect. This is for the benefit of all campers. Any of these items found in bunks will be confiscated.
3. Electronic devices such as Ipods, handheld game systems, and CELL PHONES are not allowed at camp. YOUR CHILD IS NOT ALLOWED TO KEEP THEIR CELL PHONES FOR ANY REASON. THESE ITEMS WILL BE CONFISCATED AND RETURNED AT THE END OF THE CAMP WEEK.

In addition here are several behaviors that WILL NOT BE TOLERATED at camp for the safety of all.

1. Consumption or possession of alcohol, drugs or tobacco.
2. Foul, offensive or abusive language to another camper or staff member.
3. Discrimination, harassment, or cruelty to another camper or staff member.
4. Theft or damage to property belonging to another camper, staff member or facility.
5. Physical relationships between any camper/camper or camper/staff.
6. Bodily harm or violence or any kind to another camper or staff member.
7. Consistent disregard for safety rules or disruption of camp activities.
8. Possession of any weapon, including pocket knives.

IF A CAMPER IS FOUND TO HAVE VIOLATED ANY OF THE ABOVE RULES, THE CAMPER WILL BE REQUIRED TO LEAVE CAMP. THE PARENT OR GAURDIAN WILL BE CALLED AND WILL BE RESPONSIBLE FOR REMOVING THE CAMPER IMMEDIATELY. THERE WILL BE NO REFUND OF ANY CAMP FEES.
